- The Committee discussed the applicants and unanimously resolved to offer the position of Library Manager to Andrew Naylor
- Based upon Mr Naylor's skills and experience it was decided to offer a salary starting at £35,000, however resolved to delegate salary negotiations to the Clerk, with authority to raise the scale if required. Furthermore, if the offer of employment were declined it was resolved Council would re-advertise the vacancy
- Library Assistant Remuneration: It proposed by Cllr Kilby-Shaw, seconded by Cllr O'Connor, and unanimously resolved to recommend to the full Council a salary level of £21,269 £23,484 (pro-rata)
- 26.4 Clerk Job Evaluation: The Committee used the scoring method guidance provided by SLCC and NALC salary scales

When Council was formed in 2021, Council scored 35, so NALC recommended a below substantive range of LC3 with a recommended salary scale of 33-36. Due to the current and future demands of the role which have changed over the last few years, Council now scores LC3 42, which falls above substantive. However it was recommended by the Clerk that due to assets and other considerations the Clerk job role should be classed as LC3 substantive. It was proposed by Cllr Kilby-Shaw, seconded by Cllr Ward, and unanimously resolved that the remuneration of the Clerk is moved from scale 35 to 39 with immediate effect
