25/23 KINGSTHORPE VILLAGE RE-WILDING

Cllr Lewis-Nichol explained that Kingsthorpe Conservation Committee conducted a site visit with WNC and mowing contractors to allow wildflowers to grow on grassed areas in the village, including the verge between St John the Baptist Church, KVPS and the path leading up to the school. This was agreed and will be allowed to grow wild until the end of the summer to promote biodiversity.
