101/23 REPORTS FROM POLICE REPRESENTATIVES AND WEST NORTHAMPTONSHIRE COUNCILLORS

- 101.1 PCSO Barber presented the crime report for May 2023. An increase in burglary and a decrease in criminal damage.
 - A discussion took place regarding electric scooter riders engaged in anti-social behaviour.

 PCSO Barber advised under the Police Reform Act to report the registration number and location
- 101.2 Cllr Beardsworth gave a verbal update that it was agreed at an extra meeting, that WNC plans to buy 30 homes for refugees following capital grant funding. They will also be investing nearly £5million into new advanced equipment which will help improve the authority's ability to carry out additional road maintenance. Cllr Beardsworth also advised there are increasing numbers of children coming into care and unfortunately Social Workers vacancy and turnover is still high

- 103.1 As Councils, Police Liaison Representative, Cllr Lewin gave a verbal report regarding the Annual Meeting of the online Police Liaison Representative Community Group. He also updated members regarding the new unmarked speed camera vans being trialled around Northamptonshire.

 Discussion around Northamptonshire Talking (the new name for Northamptonshire Neighbourhood Alert) with the lack of the community signing up and how can Council do more to get the message out there
- 103.2 As Councils 21 Libraries Representative, Cllr Ward gave a verbal report regarding the AGM of the 21 GLN that took place at Thrapston Community Library on Thursday, 29th June 2023. Matters raised included extending membership to a greater number of personal members due to some libraries within the county withdrawing their membership. The 21 Libraries Chair reported that she had had a meeting with Frontline Services staff where it was clarified that Northamptonshire no longer offers an inter-library loan facility, as this has become too expensive to manage
